A final conclusion should state what failed, why it failed, what evidence proves it, what restored service, and what prevents recurrence.

Engineering practices

Document the authoritative design intent, ownership, and scope for change and recovery testing.

Predict protocol and forwarding state before implementation or troubleshooting.

Validate control-plane state, installed forwarding state, and real traffic independently.

Test normal, boundary, degraded, failed, recovery, and rollback conditions.

Retain packet, configuration, counter, log, topology, timing, and service evidence.

Automate only after the manual behavior, invariants, and failure handling are understood.

Failure patterns

Treating change and recovery testing as a configuration recipe without understanding protocol state.

Checking only the local device while ignoring the neighbor, endpoint, reverse path, or remote policy.

Assuming an established adjacency or installed route proves end-to-end forwarding.

Changing multiple variables before preserving the original failure evidence.

Using vendor-default timers, trust, or policy without documenting the resulting behavior.

Closing the incident after one successful probe without negative tests or recurrence monitoring.

Validation and evidence

Examine	Topology, addressing, policy, configuration, protocol state, counters, and source authority for change and recovery testing.
