Inspect both directions and all authority boundaries; account for caching, eventual consistency, tunnels, load sharing, policy, identity, offload, time, and partial failure. Closure requires causal evidence, restored service, rollback proof, residual-risk disclosure, and prevention or monitoring actions.

Engineering practices

Define authority, ownership, scope, dependencies, and acceptance criteria for documentation and workforce readiness.

Model the expected state and traffic path before implementation or troubleshooting.

Validate intent, control state, applied policy or forwarding state, and end-to-end service independently.

Test normal, denied, degraded, failed, recovery, upgrade, and rollback conditions.

Retain topology, configuration, packet, telemetry, log, identity, timing, and service evidence.

Automate through typed data, deterministic gates, canaries, bounded concurrency, and reversible changes.

Failure patterns

Treating documentation and workforce readiness as a vendor feature instead of an end-to-end system.

Relying on intended configuration or controller state without proving applied and operational behavior.

Ignoring reverse paths, external dependencies, identity, time, or partial failure.

Changing several variables before preserving original evidence and stating a hypothesis.

Allowing automation or AI to act on stale, ambiguous, or unauthorized data.

Declaring success after one probe without negative tests, scale checks, rollback, and recurrence monitoring.
